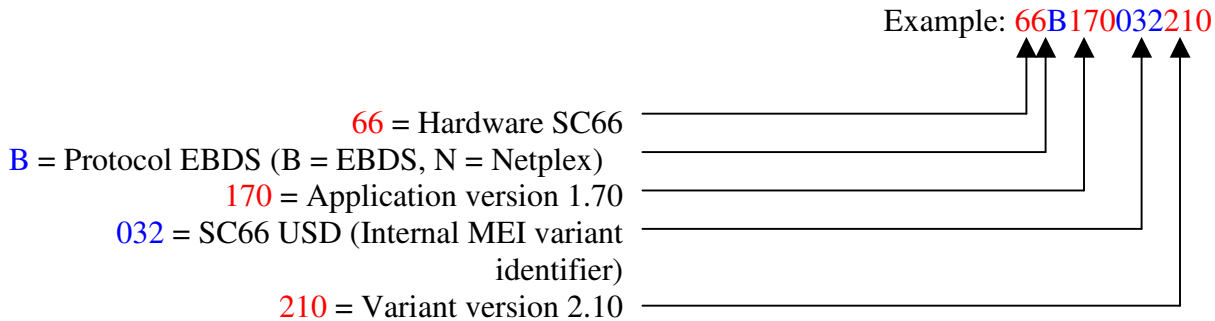
Summary:

File name configuration decoder for table 2

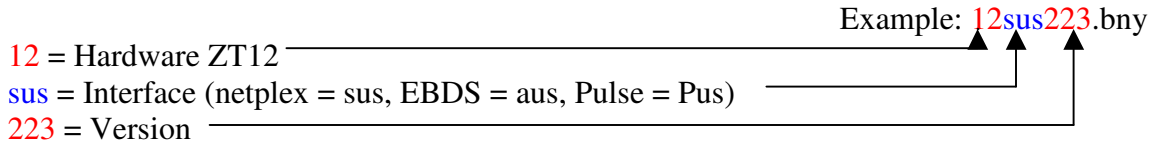
